Supporting Children During Divorce

This **Mandatory** program promotes positive strategies to support children as parents divorce.

Priorities of Mandated Program:

- Focus on the child or children's experience of divorce
- Training on specific co-parenting skills

The Program

The program will assist you in understanding and responding to the needs of your children before, during, and after divorce. Guidelines on cooperative parenting and keeping children "out of the middle" will be presented. The program will provide tools to help you have a successful co-parenting relationship with your children.

Dates and Location

The program consists of one (4 hour) session. A complete list of 2019 dates is found on the attached registration form. The program will be offered in two locations, Chilton and Appleton.

Cost and Registration

The cost of the program is \$20/per parent (cash, check, or money order), payable in advance. Enrollment is only available by person or via mail with payment (no phone calls). You will not be registered for the program until the fee has been paid. You will receive an email confirmation that you are registered for class. If you do not have an email, you will receive a letter in the mail to the address you provided on your enrollment form. Parents can be, **but do not need to be** enrolled in the same class. **Enrollment is limited. Be sure you plan ahead so you are able to enroll in the month that you want. You will need to choose another month if your initial class choice is full. Classes can be cancelled due to low enrollment or weather.**

Certificate upon completion

This certificate will fulfill the court required parent attendance needed prior to divorce finalization. A signed certificate of completion will be kept on file at the Clerk of Courts to show completion. A copy will be provided to you as well. You must attend all four hours to receive your certificate.
